#### NOTICE OF DISMISSAL OF ONTARIO SUPERIOR COURT OF JUSTICE COURT FILE NO. 16-CV-564034-00CP AGAINST MDC PARTNERS, INC., MILES S. NADAL, MICHAEL C. SABATINO AND DAVID DOFT

A shareholder lawsuit commenced in August of 2015 against MDC Partners, Inc. and certain of its current and former officers (Miles S. Nadal, Michael C. Sabatino and David Doft) in the Ontario Superior Court of Justice <u>was dismissed by Order of the Court on [DATE].</u>

The lawsuit was commenced as a proposed securities class action under the *Class Proceedings Act*, 1992, S.O. 1992, c. 6, the *Securities Act*, R.S.O. 1990, c. S.5, and pursuant to the common law. The proposed Class was defined as all persons and other entities residing in Canada or formed or registered under the provincial or federal laws of Canada, other than Excluded Persons, who acquired MDC's Class A subordinate voting shares on any domestic or foreign stock exchange or through an over-the-counter transaction during the period from October 28, 2013 to and including April 27, 2015, and who held some or all of those securities at the close of trading on April 27, 2015.

With respect to the claims brought under provincial securities legislation, the Plaintiff, Roberto Paniccia, claimed damages arising from misrepresentations in three disclosure documents released by MDC between October 29, 2014 and March 2, 2015, which were allegedly corrected by a news release on April 27, 2015. The Ontario Superior Court of Justice concluded that these claims had no reasonable possibility of success at trial. The Plaintiff is not appealing the decision and has dismissed the action.

A dismissal of the lawsuit means that it is not going forward or being pursued.

Dismissal of the action means that any applicable limitation periods in respect of these claims, which may have been suspended, began running again on the date of the Order, and either have expired or will expire.
